



## Camping Terms & Conditions

Each pitch can contain no more than 1 main unit (Motorhome / Caravan / Tent) and 1 pup tent (maximum size 2m \* 2m and must only have sleeping space).

Pitches are between 8m x 8m and 10m x 10m approximately. We reserve the right to change pitches size to suit the needs of the Mega and site conditions as and when required.

Gazebo / awnings are permitted but must be contained within your own pitch.

Parking for one vehicle, in addition to your camping unit, is permitted per pitch. Additional vehicles and trailers must be parked in the designated parking areas, as directed. A short period of time to unload/load your vehicles on arrival / departure is allowed after which vehicles and any trailers should be removed to the car park. Parking on the small pitches is only allowed if your tent and car fit entirely on the pitch and still leaves a clear safety border around the pitch, but, we would prefer you to park in the designated parking area. Access to pitch parking may be revoked should circumstances require it.

When making your booking you must let the mega team know your unit type and size if greater than 7m long. All your equipment must remain inside your pitch. You must leave a 'safety border' round your pitch as a fire break and to keep any social distancing needs in place.

Visitors must adhere to all signs and instructions during the time at the event site

Electric hook-up is for the intended pitch only, no splitters are to be used. Please follow directions as to which socket to use for your allocated pitch. No Electric vehicles are to be charged using the electric hook-ups.

Barbecues are permitted but must be raised off the ground and attended by an adult at all times. Open fires

Due to the proximity of the showground to RAF Scampton all drones, fireworks and Chinese lanterns are prohibited.

No refunds/discounts for inclement weather, late arrivals or early departures. If you need to cancel or amend your booking, please give as much notice as possible so that someone else has the chance to book.

Refunds will not be issued if cancellation is made after 30th June 2021. Up to this date, refunds will be issued but an admin fee of £30 will be deducted. You may wish to buy holiday insurance for cancellations and for your property/injury whilst away.

All pitch bookings must have at least 1 party member that is 18 years or over on 3rd August 2021.

Due to the nature of the site, anyone under the age of 18 remains the responsibility of their parent/guardian or nominated carer.

You must inform us of any changes to bookings (including, but not limited to, unit type, occupancy and dates) This should be in writing to the Mega team as early as possible, quoting your original order number.

Pets are required to be on leads at all times, when outside of your tent/caravan/motorhomes or within the camping areas, including the vicinity of the hall. This is a requirement of the landowner. You must clear up after your pet(s).

Quiet hours must be respected between 11:30 p.m. and 7:30 a.m. Radio, music and TV players must be kept at a low volume. Car doors and boots must be closed quietly. Antisocial behaviour will not be tolerated.

The team reserves the right to deny access or terminate the stay of those guests whose behaviour is deemed unsuitable.

You must notify the Lincolnshire Mega Committee on the out of hours arrivals number if you are going to arrive before 09:00 or after 19:00. The contact number will be made available on the <https://mega2021.org.uk/> Website, and on the Mega office door.

Speed limits must be adhered to at all times.

In the event of a complaint, please speak to the Mega team immediately. Complaints which are not brought to the attention of the team during your stay cannot be dealt with once you have left the site.

No arrivals will be accepted before 13:00 on Tuesday 4th August 2020. If you arrive before this time you will be turned away and will need to find a suitable place off site to park and wait. Please keep the local roads free and respect the local residents. Only vehicles displaying valid camping permits will be permitted on site.

All pitches must be vacated by 12 noon on 9th August 2020. You must take all your rubbish to the designated areas (or home). All tents, camping equipment must be cleared from your pitch and leave your pitch clear.

Chemical toilet waste MUST be disposed of at the designated Elsan points – anyone found using other facilities will be asked to leave.

In addition to these terms and conditions, all site rules must be adhered to throughout the showground, including the camping ground.

The event site is a functioning showground, visitors must be aware of onsite machinery, equipment and livestock, and must not tamper with or interfere with any equipment, property and infrastructure related to the estate or the mega event.

Please follow and adhere to all instructions given by the members of the committee, or any other site operative operating on behalf of the organising committee

The committee reserves the right to refuse entry or to remove visitors and their possessions from the site.

The committee takes no responsibility for any personal possessions, property or equipment brought onto the site.

Any lost property not claimed will be disposed of 28 days after the official end of the event

In the event of any discrepancy, the decision of the chair of the committee is final

Failure to adhere to these terms and conditions may result in your being asked to vacate the site. No refunds will be offered in these circumstances.

We reserve the right to alter these terms and conditions; all changes will be notified to anyone with an active booking in advance of the event.
